- During manufacturing LA MALTERIE DU CHATEAU SA / CASTLE MALTING products are not in contact with any genetically modified organisms or any raw materials containing genetically modified organisms.
- LA MALTERIE DU CHATEAU SA / CASTLE MALTING does not use any additives or processing aids derived from genetically modified organisms.
- The main raw materials processed by LA MALTERIE DU CHATEAU SA / CASTLE MALTING are barley and wheat which are sources from within the EU, predominantly France. No GM strains of these cereals are commercially available in the EU or France.
- As a consequence, we guarantee that the LA MALTERIE DU CHATEAU SA products are not subject to any further conditions of labelling regarding the directives 1829/2003 and 1830/2003.

Belgium's current regulations on utilization of GMOs in malt

Use of genetically modified organisms and their derivatives in food products is regulated by the European Union Regulation (EC) No 1829/2003 dated 22 September 2003. At present, only a limited number of GMOs is authorized for marketing, including several genetically modified varieties of rape, maize, cotton, and one variety of soyas. Consequently, no other genetically modified plant can be used in the food chain of the European Union at the moment. Moreover, no other genetically modified variety of a cereal can be grown for commercial purposes on the territory of the European Union at present.

In conclusion, production of malt from genetically modified barley is forbidden in the European Union. Besides, there is no sign indicating the presence of genetically modified barley on the global market.
